

LICENSE ARE SUBSTANTIALLY SIMILAR TO THE REQUIREMENTS OF THIS SECTION--; OR

(7) IS FISHING FROM--A--CHARTERBOAT-OPERATING-UNDER PARAGRAPH-(D)-(2)-OF-THIS-SECTION PURSUANT TO ANY SPECIAL LICENSE ISSUED UNDER SUBSECTION (D) OF THIS SECTION.

(D) (1) THE DEPARTMENT MAY PROVIDE BY REGULATION FOR ISSUANCE OF SPECIAL CHESAPEAKE BAY SPORT FISHING LICENSES, WHICH SHALL AUTHORIZE FISHING BY THE SPECIAL LICENSEE FOR A STATED PERIOD OF TIME, NOT TO EXCEED 3 CONSECUTIVE DAYS. THE FEE FOR EACH LICENSE ISSUED SHALL BE \$2.

(2) THE DEPARTMENT MAY PROVIDE BY REGULATION FOR ISSUANCE OF A SPECIAL CHARTERBOAT LICENSE THAT WOULD BE VALID FOR ALL INDIVIDUALS ON A CHARTERBOAT OPERATED BY A LICENSED FISHING GUIDE. THE FEE SHALL BE:

(I) FOR 6 FISHERMEN OR LESS.....\$200.

(II) FOR 7 OR MORE FISHERMEN.....\$240.

(3) THE DEPARTMENT MAY PROVIDE BY REGULATION FOR ISSUANCE OF A SPECIAL CHESAPEAKE BAY SPORT FISHING LICENSE TO A PERSON WHO HOLDS A VALID ANGLER'S LICENSE UNDER SUBTITLE 6 OF THIS TITLE. THE ANNUAL FEE FOR SUCH A SPECIAL LICENSE SHALL BE ONE HALF THE ANNUAL LICENSE FEE PROVIDED UNDER THIS PARAGRAPH (A)(2).

(4) THE DEPARTMENT MAY PROVIDE BY REGULATION FOR ISSUANCE OF AN ANNUAL SPECIAL CHESAPEAKE BAY SPORT FISHING LICENSE, WHICH WHEN PERMANENTLY AFFIXED TO A BOAT, SHALL AUTHORIZE ANY PERSON ON THE BOAT TO FISH FOR FINFISH IN THE CHESAPEAKE BAY OR IN ITS TRIBUTARIES UP TO TIDAL BOUNDARIES, EXCEPT THAT SUCH A LICENSE MAY NOT BE USED ON A BOAT WHICH HAS BEEN HIRED TO TAKE SUCH PERSONS FISHING. THE ANNUAL FEE FOR THIS SPECIAL LICENSE SHALL BE \$25.

SECTION 2. AND BE IT FURTHER ENACTED, That the Department may initially issue ~~an 18-month~~ a Chesapeake Bay sport fishing license with an effective date ~~of July 1, 1984--through--December 31, 1985~~ concurrent with the effective date of this Act to extend through December 31, 1986. The fee for this onetime license shall be \$7.50. Additionally, the Department may initially issue a 12-month Chesapeake Bay sport fishing license with an effective date of January 1, 1985 1986 through December 31, 1985 1986. The fee for this onetime license shall be \$5. This section shall have no force or effect after December 31, 1985 1986.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect ~~July 1, 1984~~ January 1, 1985.
