

(B) THE RECIPIENT OF A TEACHER EDUCATION TUITION ASSISTANCE AWARD SHALL USE THE AWARD AT AN ELIGIBLE INSTITUTION.

(C) THE STATE SCHOLARSHIP BOARD MAY ADOPT RULES AND REGULATIONS THAT ESTABLISH:

(1) PROCEDURES FOR APPLICATIONS AND RENEWALS OF TUITION ASSISTANCE; AND

(2) REQUIREMENTS THAT A TUITION ASSISTANCE RECIPIENT PROVIDE TO THE STATE ADEQUATE FINANCIAL SECURITY TO ASSURE COMPLIANCE WITH THE TEACHING OBLIGATION MANDATED BY THIS SUBTITLE.

(D) THE STATE BOARD OF EDUCATION MAY ADOPT RULES AND REGULATIONS TO DETERMINE ACADEMIC CRITERIA FOR SELECTION OF TUITION ASSISTANCE RECIPIENTS FROM ELIGIBLE APPLICANTS.

(E) THE STATE SCHOLARSHIP BOARD MAY ADOPT ANY OTHER RULES AND REGULATIONS NECESSARY TO IMPLEMENT THIS SUBTITLE.
