SUBTITLE 2. COUNTY ELECTION DISTRICTS.

1-201. DIVISION.

CALVERT COUNTY IS DIVIDED INTO 3 ELECTION DISTRICTS. ALL ELECTIONS FOR PUBLIC OFFICERS SHALL BE HELD AT THE PLACES ESTABLISHED BY THE BOARD OF ELECTION SUPERVISORS.

1-202. ALTERING COUNTY ELECTION DISTRICTS.

THE COUNTY COMMISSIONERS MAY SET THE BOUNDARIES OF THE COUNTY ELECTION DISTRICTS.

1-203. COUNTY ELECTION DISTRICT BOUNDARIES.

EXCEPT AS OTHERWISE PROVIDED BY THE COUNTY COMMISSIONERS,
