(A) IN THIS PART VI OF THIS SUBTITLE, THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(B) "COMMITTEE" MEANS THE WORKGROUP ON DAY CARE FACILITIES AND SERVICES ESTABLISHED UNDER THIS PART VI OF THIS SUBTITLE.

(C) (1) "DAY CARE FACILITIES AND SERVICES" MEANS PROGRAMS LICENSED, REGISTERED, OR OTHERWISE REGULATED BY THE STATE THAT PROVIDE DAY CARE SERVICES.

(2) "DAY CARE FACILITIES AND SERVICES" INCLUDES:

(I) FAMILY DAY CARE AS DEFINED UNDER § 5-501 OF THIS ARTICLE;

(II) A GROUP DAY CARE CENTER AS DEFINED UNDER § 14-101 OF THE HEALTH - GENERAL ARTICLE;

(III) A CHILD CARE PROGRAM LOCATED IN OR OPERATED BY A PUBLIC SCHOOL AS DEFINED IN TITLE 1 OF THE EDUCATION ARTICLE; AND

(IV) A CHILD CARE PROGRAM LOCATED IN OR OPERATED BY A PRIVATE OR NONPUBLIC SCHOOL REQUIRED TO REPORT ANNUALLY TO THE STATE BOARD OF EDUCATION UNDER TITLE 2 OF THE EDUCATION ARTICLE.
