(D)-(1) (A) A PERSON TESTIFYING COMPELLED TO TESTIFY IN A PROCEEDING TO INVESTIGATE OR PROSECUTE A VIOLATION OF §-9-307-OF THE-FINANCIAL-INSTITUTIONS-ARTICLE, ARTICLE 27, § 132 OR §§ 340 THROUGH 343 OF THE CODE, IF SUCH OFFENSES INVOLVE OFFICERS, DIRECTORS, OR EMPLOYEES OF A SAVINGS AND LOAN ASSOCIATION, OR ARTICLE--27,--§--343A--OR--§--343B--OF--THE--CODE IS NOT EXCUSED FROM ANSWERING-A-QUESTION-BECAUSE-THE-ANSWER-MAY-TEND-TO--CONNECT--HIM WITH--THE--COMMISSION--OF--THESE--OFFENSES TESTIFYING OR COMPLYING WITH A SUMMONS OR SUBPOENA BECAUSE THE ANSWER OR DOCUMENT MAY TEND TO INCRIMINATE HIM.

(D) THIS SECTION APPLIES TO INVESTIGATIONS OR PROSECUTIONS IN PROGRESS ON THE EFFECTIVE DATE OF THIS ACT, OR TO ANY OTHER INVESTIGATION OR PROSECUTION AS MAY BE AUTHORIZED BY THE GOVERNOR UNDER ARTICLE V, § 3 OF THE MARYLAND CONSTITUTION.
