~~(2) AN INDIVIDUAL WHO IS SUBJECT TO THE AUTHORITY OF THE COUNTY BOARD MAY NOT BE APPOINTED OR ELECTED TO OR SERVE ON THE COUNTY BOARD.~~

~~(3) (1) AT THE TIME OF FILING A CERTIFICATE OF CANDIDACY FOR ELECTION TO THE COUNTY BOARD, AN INDIVIDUAL SHALL CERTIFY TO THE BOARD OF SUPERVISORS OF ELECTIONS OF CALVERT COUNTY WHETHER OR NOT THE INDIVIDUAL IS SUBJECT TO THE AUTHORITY OF THE COUNTY BOARD.~~

~~(H) THE GOVERNOR MAY NOT ISSUE A COMMISSION OF ELECTION TO AN INDIVIDUAL WHO HAS CERTIFIED AFFIRMATIVELY AND WHO IS ELECTED TO THE COUNTY BOARD UNTIL THE MEMBER ELECT OFFERS PROOF THAT THE MEMBER ELECT IS NO LONGER SUBJECT TO THE AUTHORITY OF THE COUNTY BOARD.~~

~~(2) TWO MEMBERS SHALL BE APPOINTED FROM THE COUNTY AT LARGE IN 1996 AND EVERY 4 YEARS AFTER.~~

~~(F) (1) THE TERMS OF THE INTERIM INCUMBENT MEMBERS OF THE COUNTY BOARD WHO HOLD OFFICE ON OCTOBER 1, 1995 SHALL EXPIRE ON JANUARY 1, 1997.~~
