A RESOLUTION OF THE TOWN OF TRAPPE REPEALING AND RE-ENACTING, WITH AMENDMENTS, SECTION 404 OF THE TRAPPE TOWN CHARTER TO ALLOW FOR AN ALTERNATE MEMBER OF THE BOARD OF SUPERVISORS OF ELECTIONS TO BE APPOINTED BY THE PRESIDENT OF THE COUNCIL, WITH THE APPROVAL OF THE COUNCIL, PRIOR TO A VACANCY OCCURRING ON THE BOARD OF SUPERVISORS OF ELECTIONS.

A RESOLUTION OF THE TOWN OF TRAPPE REPEALING AND REENACTING, WITH AMENDMENTS, SECTION 411 OF THE TRAPPE TOWN CHARTER TO CHANGE THE DATE BY WHICH PERSONS MAY FILE A CERTIFICATE OF NOMINATION FOR ELECTIVE OFFICE FROM ON OR BEFORE THE SECOND MONDAY IN APRIL NEXT PRECEDING THE TOWN ELECTION TO ON OR BEFORE THE THIRD TUESDAY IN MARCH NEXT PRECEDING THE TOWN ELECTION.

A RESOLUTION OF THE TOWN OF TRAPPE REPEALING AND REENACTING, WITH AMENDMENTS, SECTION 412 OF THE TRAPPE TOWN CHARTER TO CHANGE THE DATE ON WHICH A PRIMARY ELECTION, MUNICIPAL MEETING OR CONVENTION SHALL BE HELD IN THE TOWN FROM THE FOURTH MONDAY IN APRIL IN EVERY SECOND ODD NUMBERED YEAR TO THE SECOND TUESDAY IN APRIL IN EVERY ODD NUMBERED YEAR.
