SHOULD ARTICLE VI, SECTION 614 OF THE TALBOT COUNTY CHARTER, ENTITLED "TAX LEVY AND BALANCED BUDGET", BE AMENDED TO INCLUDE THE FOLLOWING PROVISION: NOTWITHSTANDING ANY OTHER PROVISIONS OF THIS ARTICLE, FROM AND AFTER JULY 1, 1997, REVENUES DERIVED FROM TAXES ON PROPERTIES EXISTING ON THE COUNTY REAL PROPERTY TAX ROLLS AT THE COMMENCEMENT OF THE COUNTY FISCAL YEAR SHALL NOT INCREASE, COMPARED WITH THE PREVIOUS YEAR, BY MORE THAN TWO PERCENT, OR BY THE CONSUMER PRICE INDEX FOR ALL URBAN CONSUMERS (CPI-U) PERCENTAGE OF CHANGE FOR THE LATEST CALENDAR YEAR, DETERMINED BY THE U.S. DEPARTMENT OF LABOR, WHICHEVER IS THE LESSER? .
