A BILL TO REPEAL AND REENACT SECTIONS 20-2.25, 20-3.5(a) AND 20-6.6(b)(1), (c)(2) AND (c)(3), OF TITLE 20, FLOODPLAIN MANAGEMENT, OF THE TALBOT COUNTY CODE, TO CHANGE THE ADMINISTRATION OF THE FLOODPLAIN MANAGEMENT ORDINANCE TO THE OFFICE OF PLANNING, ZONING AND BUILDING, AND TO ALLOW CONDITIONED PERMITS FOR ACCESSORY STRUCTURES AND GARAGES UP TO 900 SQUARE FEET.
