A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF HAVRE DE GRACE, MARYLAND, ENLARGING THE CORPORATE BOUNDARIES OF THE CITY OF HAVRE DE GRACE BY ANNEXING LAND CONTIGUOUS AND ADJOINING THE EXISTING CORPORATE AREA OF THE CITY OF HAVRE DE GRACE LOCATED TO THE SOUTH OF THE INTERSECTION OF MARTIN ROAD AND SUPERIOR STREET (MD STATE ROUTE #155) AND CONSISTING OF 2.14 ACRES, MORE COMMONLY KNOWN AS THE KNOB HILL AND VISSER PROPERTIES AND PORTIONS OF MARTIN ROAD AND SUPERIOR STREET RIGHTS-OF-WAY, ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE XI-E OF THE CONSTITUTION OF MARYLAND AND THE PROVISIONS OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AND AMENDMENTS THERETO) TITLED "CORPORATIONS-MUNICIPAL"; AND TO AMEND THE APPENDIX OF THE CHARTER OF THE MAYOR AND CITY COUNCIL OF HAVRE DE GRACE, MARYLAND, BY ADDING A NEW SECTION A.17., ENTITLED "THE 2000 ADDITION TO THE CITY BOUNDARIES", ENLARGING THE BOUNDARIES OF THE CITY OF HAVRE DE GRACE.
