Huley at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged hath given granted bargained and sold released and confirmed and by these presents doth give grant bargain sell release and confirm unto him the said Thomas H. Huley his heirs and assigns forever, all the residue of the personal Estate chattels furniture implements crops and all the personal Estate whatever mentioned and described in the said mortgage Deeds with the exceptions of the said negroes therein mentioned - To have and to hold the same unto the said Thomas H. Huley, his heirs and assigns forever, and every parts and parcel thereof freed cleared released and acquitted from all claim interest and demand of him the said Lewis Ross his heirs and assigns forever - In Testimony whereof the said Lewis Ross hath hereunto set his hands and seal the day and year first above written. —



Robson, his heirs and assigns forever, my negro girl named Mary Elizabeth as slave for life. To have and to hold the above mentioned negro girl Mary Elizabeth unto the said Roger C. Robson his heirs and assigns to the only proper use and benefit & behoof of the said Roger C. Robson his heirs and assigns forever - Witness my hand and seal this fifth day of June Eighteen hundred and fifty two -
