

(B) DELEGATE DISTRICT 47B (SINGLE MEMBER DELEGATE DISTRICT):

(I) BALTIMORE COUNTY ELECTION DISTRICT 1, PRECINCTS 4, 5, 7, AND 9;

(II) THAT PART OF BALTIMORE COUNTY ELECTION DISTRICT 1, PRECINCT 3 THAT CONSISTS OF THE FOLLOWING CENSUS TRACTS AND BLOCKS:

1. CENSUS TRACT 4011.01, BLOCKS 102 THROUGH 133, 301 THROUGH 322, 401 THROUGH 405, 407 THROUGH 409, AND 416; AND
2. CENSUS TRACT 4013.01, BLOCKS 501 THROUGH 519;

(Note: The census designations describe the area in Baltimore County precinct 1-3 that is generally west of Dead Run Branch and south of Brigadoon Circle, Kent Avenue, and Johnnycake Road.)

(III) THAT PART OF BALTIMORE COUNTY ELECTION DISTRICT 1, PRECINCT 6 THAT CONSISTS OF THE FOLLOWING CENSUS TRACTS AND BLOCKS:

1. CENSUS TRACT 4007.01, BLOCKS 111, 112, AND 201 THROUGH 213; AND
2. CENSUS TRACT 4007.02, BLOCKS 101A, 101B, 102 THROUGH 108, 110, AND 111;

(Note: The census designations describe the area in Baltimore County precinct 1-6 that is generally east of Interstate 695.)

(IV) THAT PART OF BALTIMORE COUNTY ELECTION DISTRICT 1, PRECINCT 10 THAT CONSISTS OF THE FOLLOWING CENSUS TRACTS AND BLOCKS:

1. CENSUS TRACT 4005, BLOCKS 201 THROUGH 203 AND 205 THROUGH 207; AND
2. CENSUS TRACT 4014, BLOCKS 301 AND 302; AND

(Note: The census designations describe the area in Baltimore County precinct 1-10 that is south of the property line of Patapsco Valley State Park and South Hilltop Road and west of the stream that runs between South Hilltop Road and Maple Avenue.)

(V) THAT PART OF BALTIMORE COUNTY ELECTION DISTRICT 1, PRECINCT 12 THAT CONSISTS OF CENSUS TRACT 4002, BLOCKS 101 THROUGH 104, 107, AND 108.

(Note: The census designations describe the area in Baltimore County precinct 1-12 that is generally north of the railroad tracks and east of Garden Ridge Road, Belle Grove Road, Preston Court, and South Symington Avenue.)
