(Note: The census designations describe the area in Montgomery County precinct 9-7 that is generally north of Russell Odenhall Avenue.)

(II) CENSUS TRACT 7007.09, BLOCKS 205, 501 THROUGH 522, 601 THROUGH 606, AND 607A.
