

for the same & that such receipts returned to the then next General Assembly to be held for this Province shall be deemed & taken as a Sufficient discharge & Acquittance to such Agent or Agents respectively for such Sum or Sums as shall be in the said Severall & respective Receipts contained and that the said Commissioners or Trustees Appointed for Emitting the bills of Credit Established by Act of Assembly for the time being shall give Credit in the Books of the said Office for such Several & respective Sums as shall to them be so repaid by the respective Agents as af^d And that they the said Commissioners or Trustees be & are hereby made Chargeable with the said Money so repaid in the same manner as for other money or bills of Credit by them received or Lodged in the said Office for the use of the Publick of the Province af^d & that the same be Applied to any uses for which it had been heretofore Appropriated by any Law of this Province heretofore made & at the time of such repayment in force And be it further Enacted by the Authority af^d by & with the Advice & Consent af^d that the af^d Severall & respective Sums of money so as af^d to be Issued & paid to the Agents aforesaid or so much thereof as shall be Applied to the uses & purposes af^d shall be Assessed on the Taxable Inhabitants of this Province in the Publick Levy in three different Years by three Equal Portions that is to say One third Part to be Assessed in the Publick Levy which shall be in the Year of Our Lord One thousand Seven hundred & forty One & the other two third parts in the two Succeeding Years Severally And that the Severall Sums so assessed shall be Collected & Levyed of & from the Severall Taxables af^d by the Sheriffs of the respective Counties af^d and be by them paid to the Commissioners or Trustees af^d on or before the Last Day of May Yearly after such Collections together with the Sheriffs Salary of five Pounds Per Centum thereon w^{ch} money so repaid to the Commissioners or Trustees af^d by the Sheriffs af^d shall from the time of such Payments remain in the hands of such Commissioners or Trustees to the Credit of the Province & in all respects in the Condition & Circumstances as the same were before the making of this Act And for a further Encouragement for the Persons af^d Voluntarily Inlisting as af^d Be it Enacted by the Authority af^d that all & every such Person as af^d who shall Inlist & Serve his Majesty in the Expedition af^d having first received the bounty af^d by this Act Granted & after the same Expedition is over shall return to this Province within Eighteen months after his being discharged from his Majesty's Service af^d having a Certificate of such discharge & of his Good behav^r during the Service under the hand & seale of his Captain or other Superior Officer shall by Virtue of this Act from the time of his return af^d for the Space & Term of Seven Years from thence next following be Exempted from the Payment of any Publick County or Parish Taxes or Levies whatsoever & also shall be free & clear from all or any Service or Attendance in making or Clearing the High ways of this
