Thomas Coles deceased, w<sup>ch</sup> hee sayth is ffiue hund<sup>d</sup> Acres. If yo<sup>w</sup>  
find itt will not bee preiudiciall to mee yo<sup>w</sup> may lett him haue that  
instead of his 500 Acres & ualew what it is worth more, by reason  
of any howseing uppon it, or Land cleared, & take his Bill for the  
paym<sup>t</sup> of that ouerplus next yeare
