

Liber B To the worshipfull Commissioners of Charleses County the humble
Petition of Marmeduke Snow Sheweth

That whearas upon the 28th of January 1664 your petitioner did pas his word for the payment of six hundered forty and seauen pounds of tobacco and Caske and upon the behalf of brigite Heard deēd unto John foxhall of S^t Maries County Marchant for seuerall good which the sayd Brigite heard had of the sayd foxhall and the sayd heard neglecting the payment of the sūme your petitioner was Constrained by the Commissioners of S^t Maries County in No^{br} Court 1665 to pay the sayd sūme unto the sayd foxhall thearfor your petitioner Craues order of Court for the sayd debt from John Duglas as Administrator of Brigite heard and your petitioner shall pray

Whearupon John Duglas as Administrator of Brigite Heard Confesed a Judgment It is thearfor ordered that the sayd John Duglas as Administrator of Brigite Heard shall pay unto M^r Marmeducke Snow six hundered and forty seauen pounds of tobacco out of the Estate of the sayd Brigite Heard:

That your Petitioner hath sarued fūe years and upwards Com- ing in without Indenturs beeing then 18 years of Age and hath demanded his fredom with Corne and Cloaths of M^r Robert Hendly his Master but is denied the same Contrary to an Act of Assembly in that Case Prouided for the Court iudging of Saruant tims beeing neuer brought to Court in tow years time Your Petitioner there- fore humbly begs an order from this Court for his freedom with Corne and Cloaths and hee shall Pray

An order beeing sent from the Prouinciall Court to this Court to tacke the plantiues buisnes into Consideration whearupon it was Cast upon A Jury to iudge of the Plantiues Age hauing had Presi- dent thearof from the Prouinciall Court in the licke Case; A Jury was impannelled whos names are as followeth Viz M^r Thomas Al- lonson John Lambert Mathias Obrian Owen Joanes John browne George Harriss Roger Dickeson James Mackey Garrard browne Jheromie [*blank*] Thomas Wentworth Daniell Johnson

They All being Present thay wear Required by the then Judg of the Court M^r Thomas Mathews to Choose their forman who thear- upon Choas M^r Thomas Allonson for thear forman Whearupon the Jury beeing in open Court Sworne (had the whole buisnes de- liuered) to bring in a true and iust verdit According to the best of their understandings and iudgments

Who afterward Retiring and after dew Consideration had on the aforsayd buisnes; Presented themselues againe befor the Court; and
