

T U E S D A Y, November 15, 1796.

THE same members appeared as on yesterday. The honourable Charles Ridgely, of Hampton, Esquire, appeared in the senate.

A sufficient number of members to compose a senate being convened, they severally qualified in the presence of each other before Allen Quynn, Esquire, one of the justices of the peace for Anne-Arundel county, agreeably to the constitution and form of government and laws of this state.

The senate then proceeded to the election of a president. The ballot box being prepared, the ballots deposited therein, and on examination thereof it appeared, that the honourable William Perry, Esquire, had a majority of votes. Whereupon it is declared in the senate, that the honourable William Perry, Esquire, is duly elected president of the senate.

Mr. Archibald Van-Horn was appointed clerk, and Mr. Joseph Parrotte assistant clerk, who severally qualified by taking the oaths of fidelity and support to this state, the oath of office, and subscribing a declaration of their belief in the Christian religion, and also by taking the oath to support the government of the United States.

William Tuck was appointed messenger, and Edward Roberts door-keeper, and qualified as such.

The president communicates to the senate a letter from Samuel A. Otis, secretary of the senate of the United States, transmitting a copy of the journals of the senate of the United States, at the first session of the fourth congress; which was read.

The following message was read the first and second time, agreed to, and sent to the house of delegates by the clerk.

BY THE SENATE, NOVEMBER 15, 1796.

GENTLEMEN,

THE senate having a sufficient number of members to form a house, are ready to proceed on the business of the session, and to elect the governor at one o'clock this day, if agreeable to your house. We have appointed Charles Ridgely, of Hampton, and William H. Dorsey, Esquires, to join any gentlemen that may be chosen by your house to examine the ballots. John Hoskins Stone is nominated for governor by this house.

On motion, ORDERED, That the honourable William H. Dorsey, John Eager Howard and James Hollyday, Esquires, be appointed a committee to examine and report on the proceedings of the electors of the senate.

On motion, ORDERED, That the honourable Charles Carroll, of Carrollton, Charles Ridgely, of Hampton, and John Thomas, Esquires, be appointed a committee to report rules and regulations to be observed in the senate.

The clerk of the house of delegates delivers to the clerk of the senate the following message:

BY THE HOUSE OF DELEGATES, NOVEMBER 15, 1796.

GENTLEMEN OF THE SENATE,

WE have received your message of this morning, and are ready to proceed with the business of the session; we have appointed from nine o'clock in the morning till three o'clock in the afternoon for our hours of sitting. We shall be ready to proceed to the election of a governor at the hour mentioned in your message, and have appointed Mr. McMechen and Mr. Digges to join the gentlemen named by you to examine the ballots. No gentleman is nominated by this house, as governor, in addition to the nomination made by you.

BY THE HOUSE OF DELEGATES, NOVEMBER 15, 1796.

GENTLEMEN OF THE SENATE,

WE have appointed Mr. Ridout, Mr. Wilson, Mr. Robins, Mr. Wm. Thomas and Mr. Duckett, a committee on the part of this house to join such gentlemen as you may please to nominate on your part, to form a joint committee of both houses, to compare and examine all bills, from time to time during the session, as soon as they shall be severally engrossed.
