SHERMAN E. FLANAGAN, Republican, Carroll County; born in Woodsboro, Frederick County, July 29, 1899. Attended Frederick County public schools; Gettysburg College; American University; George Washington University, A.B. 1923, D.Ed. 1936; University of Maryland, A.M. 1924; Oxford University. H. S. Principal, 1921-27. Insurance broker. Chartered Life Underwriter. Police Justice, Carroll County, 1935-39; chairman, Carroll County Republican State Central Committee since 1934. Past president, Westminster Rotary Club. Member, Board of the Westminster Chamber of Commerce; Board of the Carroll County Community Chest; Masons. Married. Member of the House of Delegates, 1931-35. Appointed to the Senate in August 1955.

CLIFFORD FRIEND, Republican, Garrett County; born in Friendsville, May 13, 1896. Attended Garrett County public schools; Mountain State Business College, Parkersburg, West Virginia. Lumberman and farmer. Served in the U. S. Navy during World War I. Married. Member of the Senate, 1934-42, and since 1954.

LOUIS L. GOLDSTEIN, Democrat, Calvert County; born in Prince Frederick, March 14, 1913. Attended Calvert County public schools; Washington College, B.S.; University of Maryland Law School, LL.B. Member of the Maryland and District of Columbia Bars. Enlisted in the Marine Corps in 1942 as private, discharged in 1946 as First Lieutenant; holds reserve commission of Captain in the Marine Corps. Commissioner from Maryland on the Atlantic States Marine Fisheries Commission. Married. Member of House of Delegates, 1938-42. Elected to the Senate in 1946. Majority floor leader, 1950-54; President of the Senate, 1955-57.

PHILIP HENRY GOODMAN, Democrat, Baltimore 5th; born November 26, 1914. Attended Baltimore City public schools; University of Baltimore Law School, LL.B. 1934. Member of the Maryland Bar. Member, athletic staff of Loyola College, 1945-50. Police Magistrate, Baltimore City, 1943-48; member, Baltimore City Council, 1951-55. Member, Beth El Congregation; Nu Beta Epsilon Legal Fraternity. Elected to the Senate in 1954.

WILLIAM S. JAMES, Democrat, Harford County; born in Aberdeen, February 14, 1914. Attended Havre de Grace public schools; Tome School, Port Deposit, 1928-32; University of Delaware, 1932-34; University of Maryland Law School, LL.B. 1937. Admitted to the Maryland Bar, 1937. Trial Magistrate, Havre de Grace, 1944-46. Member, Board of Library Trustees, Harford County, 1945-53. Married. Member of the House of Delegates, 1947-54. Elected to the Senate in 1954.

GUY JOHNSON, Democrat, Cecil County; born in Elkton, May 18, 1878. Attended Cecil County public schools; Elkton Academy; extension courses at The Johns Hopkins University and the University of Delaware. Principal of the high school at North East, Chesapeake City, and Elkton. Unmarried. Member of the Senate, 1946-50; member of the House of Delegates, 1950-57. Appointed to the Senate, March 28, 1957.

FREDERICK C. MALKUS, JR., Democrat, Dorchester County; born in Baltimore July 1, 1913. Attended Western Maryland College,
