The Governor appointed this special Commission in 1968 by Executive Order to conduct a complete study of commercial registration and license fees in comparison to other states, collection and payment procedures, weight and axle classifications, and closely related matters. The Commission consists of representatives of the Senate and the House of Delegates, the Department of Motor Vehicles, the office of the Attorney General, the Maryland Farm Bureau, and other persons who have an interest in the present system and classification of commercial vehicles. The Commission is to report at a later date.

The Commission on Negro History and Culture was created by Chapter 435, Acts of 1969. It consists of seven persons appointed by the Governor from among persons who are authorities on Negro history and culture. The Governor designates both the Chairman and the Vice Chairman.

The Commission is to conduct a study of all proposals to create a better understanding and knowledge of Negro history and culture and to make recommendations to the General Assembly and the Governor. These would include the unearthing, preservation and collection of pertinent historical materials, the preparation of a catalog, and the examination of all the possibilities for the establishment of a Museum of Negro History and Culture or a Center of Negro History and Culture. The Commission is to cooperate with educational institutions within the State and make its report to the Governor and the General Assembly by April 1, 1970, at which time it will go out of existence (Code 1957, 1965 Repl. Vol., 1969 Supp., Art. 41, sec. 407).
