

CHAP. 9.

Passed Dec 10

An Act to confirm and make valid a Deed to James Ryan, of Montgomery County(a). Lib. TH. No. 5, fol. 149. A Private Act.
 (a) From Agnus Wilson, for a tract of land called *Barnitt's Desire*.

CHAP. X.

Passed Dec 13

An Act for the relief of Mary Wyatt, of Caroline County. Lib. TH. No. 5, fol. 150.

Levy authorised for her support

BE IT ENACTED, by the General Assembly of Maryland, That the levy court of Caroline county be, and they are hereby directed and empowered, at their levy court annually, to assess and levy on the assessable property of said county, a sum of money, not exceeding thirty dollars, for the support and maintenance of the said Mary Wyatt, and that the same be collected annually, by the collector or collectors of Caroline county, and paid to the said Mary Wyatt, or her order.

CHAP. XI.

Passed Dec 11

An Act to change the place of holding the Elections in the Third Election District in Caroline County. Lib. TH. No. 5, fol. 150.

Preamble

WHEREAS inconveniencies have arisen from the place of holding the elections in the third election district in Caroline county; therefore,

Place of holding elections changed

1. BE IT ENACTED, by the General Assembly of Maryland, That the judges of the third election district in Caroline county, be and they are hereby authorised and directed, to hold, in future, the elections in said district, at the place known by the name of Upper Hunting Creek, where the elections were formerly held in said district.

Acts repealed

2. AND BE IT ENACTED, That all acts heretofore passed to alter and change the place of holding the elections in the third election district in Caroline county, and for other purposes, be and the same are hereby repealed.

CHAP. XII.

Passed Dec 12

An Act to provide for repairing the Gaol in Baltimore County. Lib. TH. No. 5, fol. 150.

Levy authorised

BE IT ENACTED, by the General Assembly of Maryland, That the justices of the levy court of Baltimore county be, and they are hereby authorised and empowered, to levy and assess upon the assessable property in Baltimore county, a sum not exceeding five thousand dollars, for the purpose of repairing the gaol in said county, to be collected as other county levies, and paid over as said justices shall direct, and expended, under their direction, in repairing the said gaol, and in altering or erecting new privies appertenant thereto; and to expedite said work, the justices aforesaid are hereby authorised to borrow the above sum, if necessary, for the payment of which they may pledge the levy hereby authorised to be made.
