BE IT ENACTED, by the General Assembly of Maryland, That Levyauthorised to the levy court of Washington county be and they are hereby authorized money advanced rised and empowered, to levy annually, in the usual manner, in said by them. county, such additional sum or sums of money, as to them may appear necessary, to reimburse to the said trustees the money so as aforesaid advanced by them, and for the support and accommodation of the poor of said county, (not exceeding one shilling and ten pence halfpenny current money in the hundred pounds.) which said sum or sums of money, when collected, shall be paid over by the collector of the said county to the order of the said trustees, or a majority of them, under their common seal, who are hereby authorised and required to apply the same to the purposes herein before mentioned.
