

they experience great inconvenience for want of a sixth election district in said county, and praying an alteration in the second, third, and fifth districts, so as to admit a sixth district between; and the prayer of the petitioners appearing reasonable, Therefore, Dec. Ses. 1816.

Sec. 1. *Be it enacted by the General Assembly of Maryland,* That all that part of the constitution and form of government, made such by the act of seventeen hundred and ninety-eight, which directs that Prince George's county shall be divided and laid off into five separate districts, be and the same is hereby repealed. Part of the constitution repealed.

2. *And be it enacted,* That Prince George's county shall be divided into six separate districts, and that the additional district shall be laid off adjoining and between the second, third, and fifth districts. P. George's to be divided into 6 districts.

3. *And be it enacted,* That if this act shall be confirmed by the general assembly of Maryland, after the next election of delegates, in the first session after such new election, as the constitution and form of government directs, in such case this act, and the alterations herein contained, shall constitute and be considered a part of said constitution and form of government, to all intents and purposes, any thing therein contained to the contrary notwithstanding. If confirmed by the next General Assembly to be part of the constitution.

CHAPTER 27.

An act to alter and change the name of Cæcil Cross Roads, in Cæcil County, to Cecilton. Passed Dec. 31

Sec. 1. *Be it enacted by the General Assembly of Maryland,* That the village in Cæcil county, state of Maryland, now called and known by the name of Cæcil Cross Roads, shall hereafter be called and known by the name of Cecilton. Name changed to Cecilton.

CHAPTER 28.

An Additional Supplement to the act, entitled, An act to straighten and amend the several Public Roads in several Counties, and for other purposes therein mentioned. Passed Dec. 31

WHEREAS it is represented to this general assembly, by Jan- naro S. Farree and Benjamin Gray, of Montgomery county, that the public road leading from George-Town, through Rockville in Montgomery county, to Frederick-Town, passes through several lots of ground in the said town of Rockville, to the great injury of the holders of said lots; they therefore pray that the said road may be altered and continued through Washington-street to the north end thereof, and from thence to intersect the present road, north of the said town of Rockville, by a line drawn north 35 degrees west; and the prayer of the petitioners being reasonable, Therefore, Preamble.

Sec. 1. *Be it enacted by the General Assembly of Maryland,* That Jesse Leach, Solomon Holland and Thomas P. Wilson, be and they are hereby appointed commissioners, to lay off, and cause to be surveyed, the said road, from the north-east corner of lot No. 28, on Washington-street, in the said town of Rock- Commissioners appointed to lay off and survey a road.
