ADDITIONAL COMMENTS: Thomas Hawkins did not mention a son named John in his will, but his son Thomas's will, written in 1677, stated that the John Hawkins who became a burgess was his brother; John was probably born after his father's death, which would coincide with his first appearance in records: Foster was definitely his stepfather. MARRIED first, by 1680 Frances. Her brother was John Grosse, of Anne Arundel County, MARRIED second, by 1691 Judith, CHILDREN, SONS: John: Ernault, who married Elizabeth. DAUGHTER: Elizabeth, who married Thomas Marsh. PRIVATE CAREER. EDUCA-TION: literate. RELIGIOUS AFFILIATION: Anglican. SOCIAL STATUS AND ACTIVITIES: Gent., 1680; Esq., by 1701. OCCUPATIONAL PROFILE: planter. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, Oueen Anne's County, 1714 (elected to the 4th session), 1716-1717 (died before the 3rd session). OTHER PROVINCIAL OFFICES: justice, Provincial Court, 1697 (refused oath), sitting by August 1698-1707 (quorum, 1702-1707). LOCAL OFFICES: justice, Talbot County, 1694-1695/96, Kent County, 1696-1697; St. Paul's Parish Vestry, Queen Anne's County 1711-1712. MILITARY SER-VICE: captain, 1692; major, by 1708. STANDS ON PUBLIC/PRIVATE ISSUES: opposed the revolution of 1689; he was recommended for appointment to Council in 1707, but was never commissioned. WEALTH DURING LIFETIME. LAND AT FIRST ELECTION: ca. 1,000 acres (gave his son John 2 plantations in 1701). WEALTH AT DEATH. DIED: will probated in September 1717. PERSONAL PROP-ERTY: TEV, £1,206.5.10 (including 26 slaves and 2 servants). LAND: 1,000 acres, plus 3 plantations of unspecified acreage.

HAWKINS, JOHN, JR. (1713-1757). BORN: on August 15, 1713, in Piscataway Parish, Prince George's County. NATIVE: third generation. RE-SIDED: at "Hawkins Lot," King George's Parish, Prince George's County until 1751; on his plantation in St. Paul's Parish, Prince George's County, 1752 until death. FAMILY BACKGROUND. FATHER: John Hawkins (ca. 1690-1772), of Prince George's County, a tobacco inspector in Prince George's County in 1751. MOTHER: Elizabeth (?-1772). MARRIED first, on February 17, 1731, Susannah (?-by 1746), daughter of Rev. John Fraser (?-1742), rector of Durham Parish in Charles County from 1705 to 1710 and King George's Parish in Prince George's County by 1733 to 1742, and wife Ann Blyzard (?-after 1764); stepgranddaughter of James Smallwood (ca. 1639-ca. 1714/15). Her brothers were John (?-by 1742); George Fraser (?-1764). Her sisters were Mary (by 1709-?), who married William Magruder; Anne (1718-1779). who married in 1748 Allen Bowie; and Verlinda. MARRIED second, between 1742 and 1746 Priscilla (probably Magruder), widow of Leonard Covington (?-ca. 1742). Priscilla subsequently married by 1762 Benjamin Fendall, Esq. CHILDREN. SONS: Giles Blizzard (1732-?); John Stone (1734-1764); George Fraser Hawkins (ca. 1741-1785); and Alexander Thomas, who was a minor in 1757. STEP-SON: Levin Covington. DAUGHTERS: Ann Fraser (1736-1738): Elizabeth Lawrance: Susanna Fraser, who married William Bayly (ca. 1742-1824). STEP-DAUGHTER: Rebeckah Covington, who married Benjamin Mackall, Jr. (ca. 1723-1795). PRIVATE CAREER, RELIGIOUS AFFILIATION: Anglican, King George's Parish, Prince George's County until 1751, St. Paul's Parish, Prince George's County, 1752 until death. OCCUPATIONAL PROFILE: a merchant; in 1750 he was appointed attorney, agent, and factor for a group of merchants of Liverpool. England, PUBLIC CAREER, LEGISLATIVE SERVICE: Lower House, Prince George's County, 1753-1754 (elected to the 3rd session to fill vacancy), 1754-1756 (Accounts 1-5; Bills of Credit 5; died before the 6th session). LOCAL OFFICES: justice, Prince George's County, 1740-1757 (quorum, 1741-1757); churchwarden, King George's Parish, Prince George's County, in office 1746 and 1747: King George's Parish Vestry, Prince George's County, in office 1748-1751; St. Paul's Parish Vestry, Prince George's County, in office 1752 and 1753. WEALTH DURING LIFETIME, LAND AT FIRST ELECTION: 6,565 acres in Prince George's, Frederick, and Charles counties (ca. 334 acres by deed of gift from his parents and inheritance from his father; 886 acres through his marriage; 5,333 acres by purchase and patent). SIGNIFICANT CHANGES IN LAND BETWEEN FIRST ELECTION AND DEATH: purchased 200 acres in Frederick County, 1757. WEALTH AT DEATH. DIED: in February 1757 in Prince George's County, "after a few hours illness." PERSONAL PROPERTY: TEV, £1,923.19.0 current money (including 35 slaves, 43 oz. plate, and 3 books); FB, £1,122.12.9. LAND: 6,765 acres in Prince George's, Frederick, and Charles counties.

HAWKINS, JOSIAS (ca. 1735–1789). BORN: ca. 1735, probably at "Hawkins Purchase," Port Tobacco, East Hundred, Charles County. NATIVE: third generation. RESIDED: probably at "Hawkins Purchase," East Hundred, Port Tobacco, Charles
