No. 25. An Act to repeal and re-enact with amendments Section 827 of Article IV of the Public Local Laws of Maryland, title "City of Baltimore," providing for payment into court in certain cases of money awarded in condemnation proceedings.....	24

An Act to repeal and re-enact with amendments Section 179 of Article 1 of the Code of Public Local Laws, title "Alleghany County," sub-title "Justices of the Peace and Constables," as the same was amended by Act of 1902, Chapter 197, and by Act of 1904, Chapter 249, and to repeal and re-enact with amendments Sections 179 A and 179 B of the said two Acts, with the object of providing for the appointment of Justices of the Peace for Alleghany county, and for fixing the salaries of the Justices of the Peace for the districts comprising the city of Cumberland.....	26
