 Pillory for the space of one hour and that afterwards he receive at the publick
 whipping post twenty Lashes well laid on his bare back till the blood appears
 as a punishment for this said Crime of feloniously stealing the said Wools Accor-
 ding to the force form and Effect of the Oath aforesaid also it is considered that the said
 Isaac Ashley pay the sum of three thousand Nine hundred and thirty pounds
 of Tobacco Costs Accruing on the premises aforesaid
