

LAWS OF MARYLAND OF 1958

MARYLAND, Sct.:

At a Session of the General Assembly of Maryland, begun and held in the City of Annapolis on the Fifth day of February, 1958, and Ending on March 6, 1958, Theodore R. McKeldin, being Governor of the State, the following Laws were enacted, to wit:

CHAPTER 1

(House Bill 253)

AN ACT to repeal and re-enact, with amendments, Section 102, Sub-sections (b), (d), (e), and (f) of Article 77 of the Annotated Code of Maryland (1956 Supplement), title "Public Education", sub-title "Chapter 8. Teachers' Certificates, Salaries and Pensions"; Section 153, Sub-sections (d), (e), and (i) of said Article, sub-title "Chapter 11. County Superintendent of Schools"; and Section 213 of said Article, sub-title "Chapter 19. Source and Distribution of Income", providing for the minimum schedule of salaries to be paid to public school teachers, principals, supervising teachers, and other personnel in this State for the school year 1957-58 and thereafter; making general provision for the details of such salary payments; and generally amending the laws of this State concerning public school teachers AND STATE AID TO PUBLIC EDUCATION IN THIS STATE; TO ADD SUB-SECTIONS (C-1) AND (F-2) TO SECTION 233 OF ARTICLE 81 OF SAID CODE (1951 EDITION AND 1956 SUPPLEMENT), TITLE "REVENUE AND TAXES", SUB-TITLE "INCOME TAX", TO FOLLOW RESPECTIVELY AFTER SUB-SECTIONS (C) AND (F-1) THEREOF; TO REPEAL AND RE-ENACT, WITH AMENDMENTS, SECTION 285 (E) OF SAID ARTICLE AND SUB-TITLE; TO ADD SUB-SECTIONS (D-3) AND (D-4) TO SECTION 285 OF SAID ARTICLE AND SUB-TITLE; TO REPEAL AND RE-ENACT, WITH AMENDMENTS, SECTION 319 OF SAID ARTICLE AND SUB-TITLE, AS SAID SECTION WAS AMENDED BY CHAPTER 332 OF THE ACTS OF 1957, INCREASING THE RATE OF INCOME TAX IMPOSED IN THIS STATE, PROVIDING FOR THE USE, APPROPRIATION AND DISTRIBUTION OF THE EXTRA TAX SO IMPOSED AND RELATING GENERALLY TO THE IMPOSITION, COLLECTION, USE, APPROPRIATION AND DISTRIBUTION OF
