CHAPTER 13.

An act declaring the assent of the legislature to the devise of Lands in the Will of John Postly, late of Worcester County, deceased, to the General Assembly of the Presbyterian Church in the United States of America.

Passed Dec 18.

Sec. 1. *Be it enacted by the General Assembly of Maryland,* That the assent of the legislature be and the same is hereby given to the devise of lands in the will of the late John Postly, of Worcester county, deceased, to the trustees of the general assembly of the Presbyterian church in the United States of America, and that the said trustees of the general assembly of the Presbyterian church, in the United States of America, be and the same are hereby declared competent in law to hold the said lands, according to the intent, and for the purposes mentioned in the devise in said will, to the trustees of the general assembly of the Presbyterian churches of American United States.

Assent of legislature given to devise of certain lands.

2. *And be it enacted,* That the said trustees of the general assembly of the Presbyterian church in the United States of America, by that name and style, be and are hereby declared to be, competent in law to sue and be sued in any and every case, claim or dispute, connected with or growing out of the lands contained in the said devise.

Trustees of said church to be competent in law to sue, &c.

CHAPTER 14

A Supplement to an act, entitled, An act to authorise the Moderator and Commissioners of Hager's-Town to levy a sum of money for a Fire Engine,

Passed Dec 18.

Sec. 1. *Be it enacted by the General Assembly of Maryland,* That the officers of the Hager's-Town fire company be, and they are hereby directed, after having appropriated so much of the money authorised to be levied by the act to which this is a supplement, as shall be found necessary for the purpose therein mentioned, to appropriate and apply the remainder thereof to the repairing of the old engines, and to the purchase of such other apparatus as they in their judgment may think most necessary and useful for extinguishing fires, or in procuring such place or places for the safe keeping of their property as they may deem most expedient.

Remainder of money levied to be applied to repair of engines, &c.

CHAPTER 15.

A Supplement to an act, entitled, An act to Incorporate a Company to make a Turnpike Road from the line of the District of Columbia, where it crosses the post road leading from George-Town to Frederick-Town, through Montgomery and Frederick Counties, to Frederick-Town.
