Amendment No. 1—In line 5 of the title of the third reading file bill, immediately following the word "County", strike out the "," and insert in lieu thereof the following: "; to repeal and re-enact, with amendments, Section 47(c-4) of Article 26 of the Annotated Code of Maryland (1963 Supplement), title 'Courts', subtitle 'Salaries of Judges'; and to repeal and re-enact, with amendments, Section 5-8 of the Code of Frederick County, Maryland 1959, being Article 11 of the Code of Public Local Laws of Maryland, title 'Frederick County', subtitle 'Courts', subheading 'Article II, Circuit Court,' making provisions for the compensation of this additional judge,".
