AN ORDINANCE concerning:

**Executive Branch Organization - Fire Chief**

FOR the purpose of amending certain provisions in the Anne Arundel County Code to change the name of the Fire Administrator to Fire Chief and to have the Fire Chief be directly responsible to the County Executive.
