Bill No. 933, 2003 Legislative Session

A BILL TO REVIEW AND REALLOCATE THE NUMBER OF RESERVED ACRES OF GROWTH ALLOCATION ALLOCATED AMONG THE TOWNS FOR REZONING TO COMPLY WITH THE CHESAPEAKE BAY CRITICAL AREA COMMISSION FOUR-YEAR REVIEW REQUIREMENT.

Bill No. 934, 2003 Legislative Session

A BILL TO AMEND CHAPTER 159, ARTICLE I, TALBOT COUNTY CODE, "SMOKING", BY ELIMINATING THE EXCEPTION WHICH PERMITS SMOKING IN BAR AREAS, EXEMPTING PRIVATE CLUBS FROM SMOKING PROHIBITIONS, PROVIDING FOR PENALTIES FOR VIOLATIONS TO INCLUDE SUSPENSION OF ALCOHOLIC BEVERAGE LICENSE, AND TO AMEND CHAPTER 11, TALBOT COUNTY CODE, "ALCOHOLIC BEVERAGES" § 11-14, TO PROVIDE FOR SUSPENSION OF AN ALCOHOLIC BEVERAGE LICENSE FOR THREE OR MORE VIOLATIONS IN ANY 12-MONTH PERIOD.

A BILL TO REPEAL BILL 855, WHICH PURPORTED TO DOWNZONE CERTAIN REAL PROPERTY FROM LIMITED INDUSTRIAL (LI) TO GENERAL COMMERCIAL (GC) WITHOUT A SHOWING OF CHANGE OR MISTAKE UNDER § 190-109 B. (8), TALBOT COUNTY CODE, WHICH THE COURT OF SPECIAL APPEALS HAS DETERMINED TO BE INVALID UNDER STATE LAW.

AN ACT to amend Chapter 126, of the Wicomico County Code, titled "Forest Conservation," Section 126-4, titled "Exemptions" paragraph B, subparagraph (3) concerning single lot exemptions to comply with the Maryland Forest Conservation Act and regulations as recently revised and to require all non-residential development to have approved Forest Conservation Plans.
