

to intersect the Chesapeake and Ohio canal at the nearest and most eligible point within the District of Columbia, agreeably to the provisions of the act incorporating a company to cut the said Chesapeake and Ohio canal, as confirmed by the act of Congress at the last session.

And be it further resolved, That the treasurer of the western shore is hereby authorised and empowered, to pay to the order of the governor and council, such sum or sums of money as in their judgment may be requisite to defray the expenses of said commission, provided such sum or sums shall not exceed in amount the sum of two thousand dollars.
